Subject: IMPLEMENTATION OF 6-INCH TRAFFIC LINES AND DISCONTINUED USE OF NONREFLECTIVE PAVEMENT MARKERS

The California Department of Transportation (Caltrans) is discontinuing the use of Type A and Type AY nonreflective pavement markers and is increasing the width of all 4-inch wide longitudinal traffic lines to 6-inch wide lines for permanent pavement delineation on state highways. Section 84-2 "Traffic Stripes and Pavement Markings" of the 2015 *Standard Specifications* and the 2015 *Standard Plans* for "Pavement Markers and Traffic Lines Typical Details" have been revised for these changes. Implement these new standards by change order, if appropriate, when funds are available and no contract time extension is necessary.

To implement the discontinued use of Type A and Type AY nonreflective pavement markers, the change order must identify an equivalent 6-inch wide striping detail to be used. The table below shows the existing pavement marker detail and the replacement 6-inch wide striping detail:

This change order work should be done by agreed price. For bid item price adjustments, the increase should be between 30 percent and 50 percent of the bid item price. For replacement striping details for nonreflective pavement markers, base the extra work at agreed price on the bid price for edge stripe and adjust the price based on the increased width of the stripe required. Agreed price must be based on a force account analysis and filed in the project records.

A sample change order memorandum, sample change order, and a Federal Highway Administration (FHWA) blanket prior approval for revising striping specifications and standard plans are attached to this directive. This directive serves as delegation of authority from the Division of Construction and approval from the FHWA for this change order, except when any of the following apply to the change order:

- 1. The language is altered.
- 2. The total absolute value exceeds \$200,000.
- 3. Contract time is extended by more than 20 days.
