The North Fork from the California-Oregon border to its confluence with the Middle Fork of the Smith River, including Diamond Creek, Bear Creek, Still Creek, the North Fork of Diamond Creek, High Plateau Creek, Stony Creek, and Peridotite Creek. The Smith River System is also in the California Wild and Scenic Rivers System with the exception of Dominie, Rowdy, Savoy, Mill, West Branch and East Fork Mill, Little Mill and Bummer Lake creeks, all tributaries of the Main Stem; and Rock, Goose and East Fork Goose creeks, all tributaries of the South Fork. These tributaries (along with Hardscrabble Creek which was not included in the 1981 federal designation) were removed from the state system by a 1982 amendment to the state's wide and scenic rivers act. However, the state retained the prohibition on the development of water projects on these streams. Also, they remain in the federal system. The state-deleted tributaries, with the exception of Hardscrabble Creek, are outside the national forest boundary and mostly on private land.
