# Transportation Permits Policy Memorandum

Subject: CHP Escort Requirements for Vehicle Combinations Exceeding 185 ft

Overall Length Travelling on Yellow and Green Routes

Date: May 28, 2021 Policy: TPPM 2021-01

### **Objective**

This memorandum amends the California Highway Patrol (CHP) Escort Requirements for vehicle combinations exceeding 185 ft overall length travelling on Yellow and Green Routes. Yellow Routes are defined as multi-lane freeway or expressway with 12' -0 in lanes, 4' -0" shoulders. Green Routes are defined as non-standard freeway or 2 lane road with 12' lanes and 0' to 4' shoulders. The requirements will be clearly documented in the Transportation Permits Manual (TPM) and in the CHP Escort Requirement Table contained in the Single Trip Pilot Car Maps Legend.

# **Background**

CHP escort is required when the dimensions, listed in the CHP Escort Requirement Table contained in the Legend of the Single Trip Pilot Car Maps, are exceeded.
