Addendum No. 1

Dear Contractor:

This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN MONTEREY COUNTY IN AND NEAR GREENFIELD AND NEAR SOLEDAD FROM 0.3 MILE SOUTH OF SOUTH GREENFIELD OVERCROSSING TO 0.4 MILE NORTH OF NORTH GREENFIELD OVERCROSSING AND FROM 0.1 MILE NORTH OF ARROYO SECO ROAD OVERCROSSING TO SALINAS RIVER BRIDGE to revise the *Notice to Bidders and Special Provisions*.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Thursday, May 19, 2016.

In the *Notice to Bidders and Special Provisions*, in the "SPECIAL NOTICES," the following Special Notice is added as follows:

- " Because Labor Code § 1720.9 will affect the cost of hauling and delivering ready-mixed concrete and because Labor Code § 1720.9 applies to public works contracts that are awarded on or after July 1, 2016, the Department has included specifications regarding the new code provisions, including the method the Department will use to manage the cost impacts of the new provisions. See sections 2-1.09, 7-1.02K(1), and 7-1.02K(3) for the specifications."

In the Special Provisions, Section 2-1.09, is added as follows:

"Add to the end of Section 2-1.09:

For any bid item requiring the delivery of ready-mixed concrete in a project with a bid opening date before June 1, 2016, base your bid on the award period specified in section 3-1.04. If the Department extends the award period and the cost of any bid item increases as a result of the new prevailing wage provisions in Labor Code § 1720.9, Department makes a payment adjustment under section 9-1.04 except markups are not added."

In the Special Provisions, Section 7-1.02K(1), and 7-1.02K(3) are added as follows:

“Add to the end of the 2nd sentence of the 1st paragraph of section 7-1.02K(1):
, and hauling and delivery of ready-mixed concrete.”

“Add between the 4th and 5th paragraphs of section 7-1.02K(3):

Submitted certified payrolls for hauling and delivering ready-mixed concrete must be accompanied by a written time record. The time record must include:

1. Truck driver's full name
2. Name and location of the batch plant
3. Time the concrete was loaded
4. Time the truck returned to the batch plant
5. Truck driver's signature certifying under penalty of perjury that the information contained in it is true and correct”
