Subject: **FINANCIAL ALLOCATION FOR LOCALLY ADMINISTERED STIP TRANSPORTATION ENHANCEMENT PROJECTS ON THE STATE HIGHWAY SYSTEM (ADVANCEMENT) RESOLUTION FP-12-50**

CTC ACTION UPDATE: The California Transportation Commission approved the request for the locally administered STIP TE project on the State Highway System (PPNO 10-0016C) as described on the attached vote list.

RECOMMENDATION:

The California Department of Transportation recommends the California Transportation Commission (Commission) defer an allocation of \$550,000 for the locally administered State Transportation Improvement Program (STIP) Transportation Enhancement (TE) Main Street Sidewalks and Landscaping (PPNO 0016C) project in Calaveras County, on the State Highway System because this project is advanced from future program years.

ISSUE:

The attached vote list describes one locally administered STIP TE project on the State Highway System programmed in Fiscal Years (FY) 2012-13 and 2014-15 totaling \$550,000. Although the local agency is ready to proceed with this project, it is recommended that the Commission defer this allocation until it is known that sufficient allocation capacity is available once all the projects programmed in FY 2012-13 are funded.

FINANCIAL RESOLUTION:

Resolved, that \$550,000 be allocated from the Budget Act of 2011, Budget Act Items 2660-301-0042 and 2660-301-0890 for the locally administered STIP TE project described on the attached vote list.
